1. The **Government of the United Republic of Tanzania** has received financing from KfW towards the cost of the **Katavi-Mahale Ecosystem and Corridor Conservation Project (KAMACO)**, and intends to apply part of the proceeds toward payments under the contract for **Construction of conservation project (Katavi National park and Mahale Mountains National parks)**.
2. The **Tanzania National Parks (TANAPA)** now invites sealed Bids from eligible and qualified Bidders for the Construction works as shown in the table below:

Bidders are urged to thoroughly familiarize themselves with the Technical Specifications (in Annex 2) and with the Drawings (in Annex 4) prior to proceeding with the pricing of their Bills of Quantities (in Annex 1).

N.B: The estimated Construction Period is Twelve (12) months

3. Bidding will be conducted by means of the **National Competitive Bidding** procedure with qualification as specified in the KfW “*Guidelines for the Procurement of Consulting Services, Works, Plant, Goods and Non-Consulting Services in Financial Cooperation with Partners*” but is open to all eligible bidders, as defined in the Procurement Guidelines **Article 1.3**. In the case of foreign bidders, Procurement Guidelines **Article 2.4.3** shall also apply.
4. Registration with the **Contractors Registration Board (CRB)** of Tanzania is mandatory, with a minimum registration in **Building Class Four (4)** and above. This also applies to Joint Venture (JV) or foreign bidders who will be required to register under the temporary registration requirement as outlined by the CRB.
5. Interested eligible Bidders may obtain further information from and inspect the bidding documents at ***the Offices of Procurement Management Unit (PMU) – Attn: Shabani Semsī, Office Room No. 4, Mwalimu J.K. 6. Bidders should attend the **compulsory pre-bid meeting**, which will be held on **12th December 2025 at 10:00 Hours. (For Katavi National Park project) at the Katavi National Park Headquarters, Main Boardroom, Katavi** and also **10th Day, of December 2025 at 10:00 Hours at the Gombe-Mahale Visitors Information Centre, Kigoma. (For Mahale Mountain National Park project**
The minutes of the pre-bid meeting will be shared with all bidders who would have purchased the Bidding Documents and who attended the aforementioned pre-bid meeting. The costs for attending the compulsory pre-bid meeting shall be at the Bidders’ expense.
7. A complete set of the bidding documents (***in English***) is available to interested eligible Bidders upon the submission of a written application to the address below and upon payment of a non-refundable fee of ***Tanzanian Shilling One Hundred Thousand only (TZS 100,000.00) inclusive of VAT*** or its equivalent in freely convertible currency for each set (*per tender reference number*). The method of payment will be through **Control Number** to be provided by the Procuring Entity to the **Conservation Commissioner, TANAPA, Mwalimu J.K. Nyerere Conservation Centre Burka Estate, Dodoma Road, P.O. Box 3134, Arusha, Tanzania**. The document shall be sent by Courier (*costs to be covered by the interested Bidder*) or physical pickup by the Bidders at **TANAPA HQ, Office Room No. 04, Mwalimu J.K. Nyerere Conservation Centre, Burka Estate, Dodoma Road, Arusha**.

N.B: The bidding documents will be issued to the bidders in electronic copy. Therefore, the bidders are advised to come with pen drivers (flash disc/external drive) to collect the electronic bidding document upon payment.

8. Bids must be delivered to the address below: ***The Secretary of Tender Board's Office, TANAPA, Mwalimu J.K. Nyerere Conservation Centre, Burka Estate, Dodoma Road, P.O. Box 3134, Arusha, Tanzania at Office Room No. 4*** on or before ***2nd February 2026 10:00 hours***. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below on ***2nd February 2026 at 10:00 hours*** at ***TANAPA Board Room***.

9. All Bids must be accompanied by a "***Bid Security***" in original and in an acceptable form ***(in the amount of stated in the table below)*** or an equivalent amount in a freely convertible currency for each submitted tender valid for ***Forty-Two (42 days) beyond the bid validity period (i.e. 162 days after the bid opening date)***. The Bid Security shall be ***a Bank Guarantee***, clearly addressed to the ***Conservation Commissioner, TANAPA, Mwalimu J.K. Nyerere Conservation Centre, Burka Estate, Dodoma Road, P. O. Box 3134, Arusha, Tanzania***.
