- The Government of the United Republic of Tanzania has received a grant from the German State – Owned Investment and Development Bank (KfW) toward the cost of the Serengeti Ecosystem Development and Conservation Project (SEDCP), and intends to apply part of the proceeds toward payments under the contract for Construction of Park Infrastructures in Serengeti National Parks (SENAPA).

- 5. Bidders should attend the compulsory pre-bid meeting, which will be held on **Tuesday**, **16**th **December 2025** at 10:00 Hours at **Fort Ikoma**, **Serengeti**. This will be followed by site visits departing from Fort Ikoma at 13:00 Hours. The costs for attending the site visit shall be at Bidders' expense. The minutes of the pre-bid meeting will be shared with all bidders who would have purchased the Bidding Documents.

- 6. A complete set of the bidding documents (in English) is available to interested eligible Bidders upon the submission of a written application to the address below and upon payment of a non-refundable fee of Tanzanian Shillings One Hundred Thousand only (TZS 100,000/=) or its equivalent in freely convertible currency for each package (per tender reference number). The method of payment will be through Control Number to be provided by the Procuring Entity to the Conservation Commissioner, TANAPA, Mwalimu J.K. - 7. Bids (in one original plus two copies) must be delivered to the address below: The Secretary of Tender Board's Office, TANAPA, Mwalimu J.K. Nyerere Conservation Centre, Burka Estate, Dodoma Road, P.O. Box 3134, Arusha, Tanzania at Office Room No. 40 on or before Monday, 02th February 2026 10:00 hours. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders designated representatives and anyone who choose to attend at the address below on Monday, 02th February 2026 at 10:01 hours at TANAPA Board Room.
- 8. All Bids must be accompanied by a "Bid Security" in original and in an acceptable form (in the amount stated in the table below) or an equivalent amount in a freely convertible currency valid for Forty-Two (42 days) beyond the bid validity period (i.e., 162 days after the bid opening date). For Bidders interested to apply for more than one package, they shall be required to submit one comprehensive bid security summing the total amount mentioned in each package of his/her interest. The Bid Security shall be a Bank Guarantee, addressed to the Conservation Commissioner, TANAPA, Mwalimu J.K. Nyerere Conservation Centre, Burka Estate, Dodoma Road, P. O. Box 3134, Arusha, Tanzania.
